

2023 Press Start Composer Competition Terms & Conditions

Overview

Beginning at 12:00 a.m. Eastern Time ("ET") on July 5th, 2023 through 11:59 p.m. ET on August 18th, 2023, Press Start will accept original Submissions from eligible composers/arrangers (each, a "Contestant" and collectively, the "Contestants"). Judging will take place in accordance with the method and procedure described in the "Judging" section below. This competition is a skill-based contest and the element of chance will not be present at any stage of the Contest.

By entering the Contest, and/or making a Submission to the Contest, Contestants shall be deemed to have consented to the Rules.

Eligibility Requirements

Contestants must be 18 years of age or older and reside within the United States.

How to Participate

Contestants will compose a video game track using a selected list of melodies as inspiration. (Please note that Contestants do not need to use the provided melody in its original form.) The composition will be written for any combination of the following instruments: Flute, Oboe, Clarinet, Bassoon, Horn, Violin, Viola, Cello, with a maximum of 2 players per instrument. The ensemble size can range from 2-9 players. Contestants will then upload program notes, two full scores, a copy of each instrument part, and a MIDI playback representation. In order for a submission to be considered, the Contestant must sign and submit this acknowledgement agreeing to the terms and conditions.

Submission guidelines

Contestant or the individual submitting the composition represents and warrants that each submission (including the sound recording embodying the composition) is original work of the Contestant, except for the protected elements from "Celeste," and must not infringe upon the rights of any third party, including, without limitation, copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity. Press Start reserves to disqualify any submission they determine, in their discretion, fails to satisfy any of the requirements.

Except for Contestant's use of provided melodies, the submissions must be an original work created by the Contestant. Content cannot contain any material that infringes on the intellectual property rights of any third party. Content cannot contain copyrighted materials owned by others (including recordings, sampling or "scratching" and other works published or used on or in websites, television, movies or similar media). Content cannot contain materials embodying the names, voices, or other indicia of, or identifying, any person, including, without limitation, celebrities and/or other public or private figures, living or dead.

Judging

Submissions will be collected by a neutral mediator who will present anonymous copies of score and MIDI files to the adjudicating panel. The adjudicating panel will include select Press Start Board members ("the Board") and any guest judges invited by the Board, excluding the chosen mediator. The adjudicating panel will come to a consensus to select finalists from the full pool of submissions, from which the winner/award recipient will be selected.

Award recipients may not substitute, assign or transfer the award, but Press Start reserves the right, at its sole discretion, to substitute any award (or portion thereof) with one of comparable or greater value. Award recipients are solely responsible for all applicable federal, state, and local taxes, if any, as well as any other costs and expenses associated with Submission entry, award acceptance, and use not specified herein as being provided. Winners may forfeit a prize prior to acceptance. Press Start shall not have to re-award a prize in the event of a winner forfeiture.

License

Entering the Contest does not transfer any ownership rights to Press Start. Notwithstanding the foregoing, through making a Submission, Contestants grant Press Start a non-exclusive, worldwide, irrevocable, unlimited, royalty-free, sub-licensable right to display, distribute, dispose of, exploit, reproduce, host, transmit, publish, publicly perform, edit, adapt, perform, modify, copy, disseminate, and otherwise use the Submission, including, without limitation, the copyright in the sound recording and the underlying musical composition embodied therein and any and all ancillary and subsidiary rights therein, online or in any other media now known or hereafter devised, for Press Start's advertising, publicity, and promotion of Press Start and Press Start contests, without additional compensation and without permission or notification to Contestant. For the avoidance of doubt, Contestants acknowledge and agree that upon entering a Submission, the Contestants' name will be publicly released as part of the dissemination of the Submission, associated marketing materials, and/or as identification of a winner, and without limiting the foregoing grant of rights. Contestants grant Press Start the right to publicly disclose all of the foregoing for the purposes stated herein. Notwithstanding the foregoing, nothing in this paragraph shall restrict Press Start from having a Contestant provide an Affidavit of Eligibility, Liability and Publicity Release as otherwise set forth herein.

Nature of Relationship

Nothing in these Rules or any other agreement with the Contestant shall be deemed to create an employment or agency relationship between Press Start and the Contestant. The Contestant hereby acknowledges and agrees that the relationship between the Contestant and Press Start and any of its designees is not a confidential, fiduciary, or other special relationship, and the Contestant's decision to provide a Submission does not place Press Start in a position that is any different from the position held by members of the general public.

Release of Liability

By entering the Contest, the Contestant agrees to release and hold harmless Press Start from all claims, liability or damage caused or claimed to be caused, in whole or in part, directly or indirectly, in connection with participation in this Contest, or acceptance or use of any award, the administration of the Contest, the operation of any website (including the Press Start Website) or Press Start use of any of the rights granted herein (including any claims arising out of the use of third party content that may be embodied in a Submission).

Termination & Modification

Press Start reserves the right to modify, suspend or terminate the Rules, Contest or a Submission at any time without liability to the Contestant, including, without limitation, in the event Press Start becomes infected by a computer virus or is otherwise technically impaired, and to cancel or suspend the Contest in its entirety should tampering, unauthorized intervention, fraud, technical failures or other causes corrupt the administration, security, fairness, integrity or proper play of the Contest. Press Start reserves the right at its sole discretion to disqualify any individual it finds to be tampering with the Submission process or the operation of this Contest or any website (including the Website), intending to annoy, abuse, threaten or harass any other Contestants, Press Start or any of its representatives or to otherwise be acting in violation of these Rules and void all associated Submissions.

Some jurisdictions may require enforceability to make available to you written copies of the rules, the prize winner's name (if applicable and a prize is not forfeited), and other similar information.
